## III. CURRICULUM/PROGRAM

#### A. GOOD NEWS IN OUR SCHOOLS:

#### District-Wide

• The Stevenson and Churchill Staff participated in an hour long boot camp class to raise money for medical expenses for one of our 5th grade students. Staff members who participated, donated \$10.00 each to complete a heart healthy workout. As a district \$600 was raised to help the family. The event was coordinated by Nicole Messina.

#### Churchill School

- Students in each grade met with Mr. Smatla (and their grade level teachers) for their quarterly "grade level meetings" to discuss how to improve effort and performance.
- For a previewing activity, before the start of the Tolerance/WWII unit in the 6th grade reading unit, Ms. Eisenberg came in to read a biography and share her mother-in-law's experiences going through the concentration camps during the Holocaust. Students were given the opportunity to ask questions. They became very motivated to start the unit on the subject.
- Mrs. Eisenberg's Grade 6 Math class has been working diligently on the IXL math program and xtramath.org program. Students are gaining strength in many skills.
- Students in grade 6 have been working on a differentiated research report on Ancient Egypt (13 options). They also have a hands-on activity as a component. They have been working on it for the past month and the presentations are next week.

- Over 90% of the 5th graders aced their unit 4 math test on decimals and place value!
- Students in Ms.Malinowski's class were rewarded with a breakfast/game party for being a "Good Choices Class" for the first half of the year!!
- Fifth grade students wrote biography dialogues in library class, after researching two historical figures. Dr. Seuss had a conversation with cartoonist Charles Schulz, Ruby Bridges and Cece Bell discussed their experiences with prejudice, and author Jeff Kinney talked to TV inventor Philo Farnsworth.
- Fourth grade students in library class read novels of many different genres, written by award-winning authors Avi, Marion Dane Bauer, Ursula Le Guin, Andrew Clements and others and presented the books to their classmates.

#### Stevenson School

- Kindergarten students participated in a two-week chick hatching project. They were introduced to this unit of study by Farmer Dan from Quiver Farms. He brought in 24 eggs and all of the equipment needed to hatch baby chicks. He also brought a hen and rooster so the children could meet the chicks' parents. Students were amazed as they watched our chicks hatch from their shells! This was an exciting time for the students.
- The first grade students were busy learning about Abraham Lincoln and George Washington and their contribution to the country. The students also learned how to locate Fairfield, Trenton, and New Jersey on the map. Also, a dentist came to visit for Dental Hygiene Month where the first graders learned about proper care for their teeth.
- Ms. Franzi & Mrs. Dillon's classes wrote an informational piece about penguins. The first graders watched a video and read several penguin books and recorded important penguin facts. Then, they wrote their informational piece in their writing journal using a topic sentence, two details, and closing sentence. Last, the first graders typed their writing while also adding a border and changing the font.
- Second grade students completed a three paragraph narrative based on being trapped in a snow globe. Writing included a hook, narrative details, and an extended ending. Their work is on display in the second grade hallway complete with detailed artwork that includes their photo. Second graders have recently begun opinion writing based on three famous African Americans that they studied; Ruby Bridges, Martin Luther King Jr., and George Washington Carver. Students were instructed to write about the one thing they believed made the greatest impact on our country. After reading about Ruby Bridges, each class watched the movie adaptation and discussed the similarities and differences between the two.

• The 3rd graders participated in an Animal Research Project. With help from Ms. Goodman, the children chose books from the library on the animals they chose to research. Using the Empowering Writers Expository Pillar, each student described the animal's habitat, characteristics, and diet. Each student had to use an internet source to look up the animal's life cycle. They had the option to cut and paste or illustrate the life cycle. The children then presented their interesting facts paragraph to the class about their animal.
